



ACKNOWLEDGEMENT AND ASSUMPTION OF RISK FORM TRAVELING / HIKING / BOATING ACTIVITIES

I understand and accept that traveling, hiking, and cultural immersion activities expose me to numerous known and unanticipated risks which could result in personal injury, illness or damage to myself, or my property. Some of the risks or factors creating risk include, but are not limited to the following:

- The hazards of traveling by foot in rugged terrain
- Backcountry hazards including loose rocks, falling trees, and river or creek crossings
- Man-made objects in the area including but not limited to: barbed wire, other fences, vehicle and foot bridges, building remains
- Consumption of local food and water
- Participation in activities such as operation of a bicycle, walking amongst vegetation and the exploration local villages
- Hiking, walking or running in rugged terrain, including slippery rocks and vegetation
- Injuries inflicted by animals, insects, reptiles, plants, or other biological means
- The forces of nature including lightning, weather changes
- Sunburn, high winds, and others not named
- The physical exertion associated with the outdoor activity
- Presence of urban traffic and potentially dangerous road crossing

This hiking tour is on moderately strenuous level. Participants were informed before the trip about the length of the trail. Participants should be prepared to hike over rocky, sandy, and sometimes exposed terrain.

By signing the form below, I agree to accept and assume all responsibility for and risk of personal injury, illness death or damage to myself or my property arising from my participation in this traveling, boating, hiking and cultural immersion activity. My participation is voluntary. I choose to participate in this traveling, boating, hiking and cultural immersion activity in spite of these named and unnamed risks.

I am aware of my health and physical condition and I am physically prepared for full participation in the activity. I am solely responsible for deciding to participate in this activity. I understand my responsibility in decision-making. I agree to obey all Prague Hiking Tours rules and regulations while participating in this traveling, hiking and cultural immersion activity.

WAIVER AND RELEASE OF LIABILITY- I hereby WAIVE AND RELEASE ALL LIABILITIES, CAUSES OF ACTION, CLAIMS AND DEMANDS against Prague Hiking Tours and its employees, where such LIABILITIES, CAUSES OF ACTION, CLAIMS AND DEMANDS arise in any way from any injury, loss or harm (whether foreseen or unforeseen) that occur to me or to any other person or to any property during the Hiking Tour or are in any way related to the Hiking Tour. I also agree NOT TO SUE or make a claim against the Prague Hiking Tours for death, injuries, loss, or harm that occur on the hiking tour, except for suits or claims related to gross negligence, intentional or reckless misconduct.
